***15. TERMS & CONDITIONS (Read Carefully):**

- I.** Payment of fees should be made on or before the prescribed date notified by the Authority. If the candidate fail to pay the fees within the schedule prescribed date, the same may be allowed to pay with respect to the following date.

Schedule & Fine :

- (a) Within 1 month after the prescribed date, Rs. 500/-
(b) For the next month (2nd month), Rs. 1000/-
(c) For the 3rd month after the prescribed date, Rs. 2000/-

However after 3 months the candidature sheet of the student, who have failed to pay the dues, will be cancelled.

- II.** Amount once paid towards Admission/Programme Fees is neither refundable nor transferable under any circumstances.
